I also acknowledge, in accordance with the Income Tax Act and Canada Revenue Agency guidelines, that no benefit of any kind has been provided to me, or to anyone designated by me, as a result of this gift

My gift will be facilitated by United Jewish Appeal of Greater Toronto (UJA), who will allocate the funds via the Jewish Federations Canada - UIA.

Please note that the following steps, which will be involved in remitting the funds to organizations in South Africa, have been established in order to comply with Canada Revenue Agency (CRA) regulations.

1. UJA will forward the donation monies to the Jewish Federations of Canada – UIA (JFC-UIA) national office, which is the agency responsible for transferring funds to organizations in Israel and overseas on behalf of all UJA/CJA Federations.
2. JFC-UIA will contact the organization in order to ensure that it complies in all respects with CRA regulations.
3. The organization will be requested to provide a project proposal and budget for the application of the proposed donation.
4. JFC-UIA will review the project proposal and budget to ensure that it meets CRA requirements.
5. Provided that the proposal and budget are found in accordance with CRA regulations, the organization will be asked to sign an agency agreement for the specific application of these funds, based on the previously approved project proposal. Please note that the organization may begin the program for which the funds are being provided, only after it has been notified of this approval.

The JFC-UIA is only permitted by CRA to reimburse organizations after they carry out the funded activity and provide a financial report (including copies of invoices to evidence expenditure or alternatively by providing a CPA audited authorization of the financial report).

6. Transfer of funds from JFC-UIA will be by direct wire transfer to the bank account of the organization, in the currency of the donation.

The critical issue that determines the speed by which a donation is reimbursed to an organization is the response time of that organization in providing JFC-UIA with the required information. The organization's level of preparedness for the CRA requirements will directly impact the timing of the transfer.
